Introduction to Programmatic Upload Filing

For surplus lines agencies with high-volume filing needs, SLTX's **SMART** application offers an alternate bulk filing process. This submission procedure enables an agency to upload previously created policy and transaction data files from their own system to SMART by either utilizing the web site for manual uploads or via client-side programming for automated file transfers to the system.

This reference document provides the resources and record layouts needed for constructing and transmitting these types of file packages to SLTX through the SMART application. A certain level of programming knowledge is assumed: instructions for extracting data and writing code to automate these transfer functions will not be found in this text.

The SLTX code files for Transaction Codes, Action Codes, Coverage Codes, Class Codes, Company Codes, and Syndicate Codes are available to the programmatic filer as API requests. These are programmatic replacements of the existing Master Codes Lists such as the former EFR1005 Report. Additionally, these code listings are available within SMART's Search/Edit module. These codes can be used to build a cross-reference of SLTX codes to agency database codes.

The programmatic-filing approach follows many of the same submission procedures as used by web filers. However, there are marked differences. All manual transaction-entry procedures and some of the web-based Batch Management rules are by-passed. Once Agency Profiles and User Profiles are established in the system, programmatic filers will use the web site to check batch-processing results, download posted transactions and error files, make corrections, and access necessary reports.

Programmatic File Transmission Process

Overview

SMART uses a JSON API with a Swagger UI.

All requests use Basic Authentication with your user ID and password that is shared between SMART and the legacy Electronic Filing System (EFS).

ALERT! Adequate testing is required within the Test Environment. It is necessary for you to successfully demonstrate (or test) any features, as well as all products (coverage/class) and insurers, that will be automated (or submitted via the API). After sufficient, successful submissions and postings, the SLTX Help Desk will activate your agency in the live production environment. Any entries made in our test environment are for testing purposes only and will not be copied or transferred to the live production environment.

Support

SLTX will provide basic review and advice related to the resolution of obvious data or format related defects.

Unfortunately, at this time, SLTX is unable to provide in-depth support / work for any filer or vendor that elects to fully automate the XML submission as this level of support and/or modification to your existing code base exceeds the licensing, legal liability, and cyber risk threshold that SLTX is currently allowed to operate under. If you are unable to fully automate the XML submission, you may utilize the "Upload API Filings" feature from SMART's filing menu to submit your prepared XML file.

SMART Connector

SMART Connector is a desktop utility that will perform the programmatic filing process for users of Vertafore's AIM.

Installation is available by contacting SLTX.

Once installed, SMART Connector can be executed as often as desired to send transactions to SMART. This process should be done at least once a month to avoid late filing.

The SMART Connector application will guide you through the filing process. You will need a login to your AIM Database, a SMART (or EFS) login, and you need to perform some product and company mapping up front in order to upload.

Product Mapping

A feature that allows the SMART Connector user to pair or map AIM product and company codes to SLTX Coverage/Class or Company codes.

While this feature is referenced within the SMART API Swagger page; this feature is solely used by the SMART Connector.

The following schedules show all necessary code and data requirements to be used when assembling policy information for each individual type of transaction that you might submit to SLTX. Codes

New Policy Replacing Binder	TransType = "N"	ActionCode = "PR" (Policy Replacing Binder)
Renewal Policy Replacing Binder	TransType = "R"	ActionCode = "PR" (Policy Replacing Binder)

An important note to agencies/brokers about this transaction is that the policy replacing a binder action code, PR, will automatically cancel the Binder, which will remove the money, including tax and stamping fee. Then, the money on the transaction sent by the agency/broker will be put on the Policy that replaces the Binder. It is not necessary to submit a cancellation of the Binder, but it is necessary to provide the premium, tax, stamping fee and total gross. A blank, or value of zero, is allowed in these fields only when there is not a premium.

Binder

If the Policy Number of the Policy is different than the Binder Number, then put the Binder Number in Binder and Policy Number in PolicyNumber.

If the Policy Number and Binder Number are the same, then only the PolicyNumber field must be provided.

InceptionDate

If the Effective Date on the Policy is different from that of the Binder, then put the Policy's Effective Date in InceptionDate and the Binder's Effective Date in EffectiveDate.

Special Situations

CustomID / ReverseCustomID / ParentCustomID / BinderCustomID

CustomID – It is strongly recommended to always provide a CustomID for every filing. This must be unique; it is suggested to use something meaningful from your filing system such as an invoice id. When processing a Delete transaction, you are required to provide the CustomID of the item that you are deleting.

ReverseCustomID – It is strongly recommended for reversals in order to mark which transaction is being reversed. When reversing the ParentCustomID must also correspond to the Policy or Binder. Which means when reversing a Policy or Binder the ReverseCustomID and ParentCustomID will be the same value.

ParentCustomID – It is strongly recommended for anything filed against a parent (non-policy or “child transaction”), for example endorsements or cancellations to mark which policy is being modified by the child transaction. When filing a Policy Number change this **must** be provided.

BinderCustomID – It is strongly recommended that this be provided when filing a Policy Replacing Binder to point to the original Binder.

Securities

Company – Securities will consist of at least one company, CoNumber, and ParticipationPct. The total of all the ParticipationPct fields for each company used must equal 100% for a transaction. Each company participation must be in percentage format and can be up to 6 decimal places. Example: “35.156413”, or “100”

Syndicate – If one of the companies is Underwriters at Lloyd's London, then at least one Syndicate CoNumber is required.

A company or syndicate must be eligible at the inception date of the policy. If it is not, it will be indicated at posting. See the Status field in the Company and Lloyd's Syndicate transaction information.

Coverages

Coverages consist of a coverage code, CvgCode and coverage (premium) amount, CvgAmt. If a coverage code is used, the amount must be provided even if it is 0.00. Noting that the CvgAmt is the premium amount for the Coverage Code, not the policy limit.

SMART can handle more than 5 coverage codes on a policy. However, if this policy is viewed in EFS only 5 will display, and if it is modified in EFS then potentially some coverages will be lost.

PremiumAllocation

Exempt Premium (EX) – premiums that are exempt from taxation. Exempt premium is premium on risks, or exposures, that are properly allocated to federal waters, international waters, or that fall under the jurisdiction of a foreign government and are not taxable in Texas as defined in the Comptroller of Public Accounts bulletin 94-142 entitled “Surplus Lines Tax Exemptions/Preemptions”.

“Breakdown of States Summary” Premium (BS) – **breakdown of states summary** of premium allocated to risks other than Texas (NRRRA – When Texas is the home state, all premium is reported and taxed as Texas, and additionally required is the summary of premium allocated to other states). In addition to the summary of the premium allocated to other states, is the breakdown of the individual states that make up that summary.

State Code – premium allocated to risks other than Texas, break down by individual states (required, in addition to **breakdown of states summary** amount) For example: OK for Oklahoma, NY for New York, OR for Oregon.

ZipCode

The ZipCode is a required field on any policy, binder, cover note, or date extension (*regardless of the coverage or line of business*). This must be this zip code of the *risk location* and must be a valid Texas zip code. This is NOT the zip code of the mailing address, nor the zip code of a PO Box (even if shown as the premises of risk location). For multiple locations, use the single risk location zip code for the highest risk or premium. It is not necessary to submit a risk location zip code on an endorsement, unless it is different than the original submission or if a new location is being added.

WindStormExclusion

The WindStormExclusion flag works in conjunction with the Zip Code to override the Extended Coverage Territory Code associated with the Zip Code used. If the policy/binder has a Windstorm Exclusion, this flag should reflect Yes. If the Coverage does not require Extended Coverage this field is ignored but can be empty or not provided.

PrevAgLicNo

The Previous Agent License Number should be provided when 'Change Agent of Record' flag is marked 'Yes' and when there are Multiple parent policies. If the PrevAgLicNo is not provided when Multiple parent policies exist, the transaction will be tagged, directing the agent to contact the SLTX Help Desk to assist in identification of the matching parent policy.

ECP

Exempt Commercial Purchaser (ECP) – This Yes/No flag should indicate if the insured meets the criteria as an Exempt Commercial Purchaser. (A surplus lines agent is not required to meet the Texas diligent effort law if the buyer qualifies as an exempt commercial purchaser under the NRRRA.) It will be required that you provide this information if the insured qualifies, and *if* the agency elects to utilize this exemption. Note: *This is not the same as Exempt Premium.*

IndustrialInsured

This Yes/No flag should indicate if the insured meets the criteria as an Industrial Insured. (A surplus lines agent is not required to meet the Texas diligent effort law if the buyer qualifies as an industrial insured.) It will be required that you provide this information if the insured qualifies, and *if* the agency elects to utilize this exemption. Note: *This is not the same as Exempt Commercial Purchaser.*

PurchasingGroup

This Yes/No flag should indicate if the insured meets the criteria as a Purchasing Group. (A surplus lines agent is required to submit Purchasing Group policies if the member with the highest risk resides in Texas.) It will be required that you provide this information if the insured qualifies.

PolicyLimit

This field allows numeric characters and records the highest aggregate limit for the policy. Limits are required to be recorded in accordance with TAC 15.106 for policies effective on or after 12/30/2018.

ReEntry

This Yes/No flag indicates this is a re-entry due to correction. SMART uses the CustomID to designate the original filing that is being corrected. This will automatically populate the PolicyID of the original filing on this later re-entry, which will be used for the Monthly and Annual Late Filing Report purposes.

XML File Formats

XML Basic Concepts

Any XML file used for transmitting data to SMART must follow the W3C XML specifications. The goal of this section is to define the various XML requirements as used by SMART. It is beyond the scope of this manual, however, to explain all XML concepts. For details and technical specifications, please visit the W3C web site at <http://www.w3.org/XML>. This site offers information on specifications but does not provide tutorials or other instructions in preparing XML files.

Escaped Characters

Please note that certain data characters must be escaped when constructing an XML file. For example, the less than symbol (<) and greater than symbol (>) have special meanings in XML—they are utilized to delimit the element tags. When data should contain one of these special characters, the symbol must be encoded using the appropriate predefined entity (see W3C XML specifications):

Batch Reports are not part of the initial API release and will be included as part of a later release. However, additional status features have been added to SMART to immediately facilitate review and analysis of posted items.

ASCII (or tab delimited) batch filing is not included within the first release. Further polling will occur to determine need and/or requirements for a secondary or tertiary phase.

The primary change is now CustomID can be provided and used as a unique identifier from Agents rather than TransID being allowed as a matching element.

Automated or programmatic "Correction Batches" are removed. Any "Correction" to a pending or errored transaction should be handled via the web application. (NOTE: no existing EFS broker utilized "programmatic filing" to correct errors).

Transactions effective prior to 07/21/2011 (NRRRA implementation) are no longer supported through the API. These transactions must be manually entered through the SMART system.

Removed Batch Delete capability as this activity is not performed by automated filers and is instead solely used via "web entry".

XML Schema changed:

- Now uses namespace called SMART
- Removed EfsVersion element
- Tightened XML validation for zipcodes to allow only specific 5 or 5-4 formats
- Removed batch attributes requirements for Item Count, Total Gross, and Agent License Number
 - These fields may still be provided, but are no longer required
- EFSPolicy renamed to Policy
- PG renamed to PurchasingGroup
- Removed ChgValue
 - Since CustomID is the identifier the original field names are used for changes. For example, Insured Name change has a ParentCustomID which must match the Policy's CustomID and the InsuredName element will be the new Insured Name.
- DupParentID removed: use ParentCustomID
- CorrectionReEntry and CorrectionReEntryPolicyID removed. Use ReEntry flag to re-enter policies and use the same CustomID to ensure uniqueness. This simplified process will act in the same manner when specifically relating to the Monthly and Annual Late Filing Report.
- Companies and Syndicates no longer have a Status attribute
- Coverages are no longer limited by 5
 - While SMART has no limit, if this policy must be viewed or modified in EFS then EFS will still limit to 5.
- Removed Tags and DupParents because Correction Batches are removed
- Download features not included; to not include the following from this release:
 - TransID
 - TransPolicyID
 - PolicyIneligibleCo
