SUMMARY

Report to the Director of Information & Technology Services. The Front-End Developer is a key member of the Development team and works closely with operations to ensure tasks stay on track. Design, develop, and implement enterprise software solutions that address specific needs of projects assigned. Ensure that all development practices are compliant with established practices, policies, and procedures. While this is a front-end focus position, duties related to other areas within development may be necessary to complete other tasks.

ESSENTIAL RESPONSIBILITIES

- 1. Maintain and optimize application features.
- 2. Recommend appropriate tools, technologies, and processes for development of scalable and software solutions.
- 3. Collaborate with internal and external development teams to plan, design, develop, test and maintain SLTX's front-end web/desktop-based software application.
- 4. Assist in development and documentation of front-end user's requirements, stories, and estimate time.
- 5. Work independently or with input on new features, bugs, and enhancements.
- 6. Participate in peer-reviews of solutions designs and related code.
- 7. Display excellent communication and written skills.
- 8. Create and complete application development by coordinating requirements, schedules, and activities.
- 9. Collaborate in team meetings, troubleshooting development, assessing and correcting production problems across multiple environments and operating platforms.
- 10. Remain motivated to learn and grow, keeping well-informed of the latest technologies and best practices as well as industry trends and technologies.
- 11. Performs other duties as assigned.
